Overview Narrative:

The following summarizes committee work accomplished throughout this past year:

Request for Consultations and/or topics reviewed by the committee and outcomes (topics reviewed by the committee decided not to act/review should be listed here with, no action taken):

Members discussed concerns about the three committee vacancies as of Summer 2023 and agreed that a full committee of seven members was essential. The committee chair reviewed this concern with the Senate President, who indicated his support for an election to fill these vacancies, but nothing materialized. In addition, through informal networks established among committee members, academic professionals were able to participate in the spring assembly elections held in March 2024. Some academic professionals were not apprised of nor furnished with essential election information, demonstrating persistent gaps in disseminating election-related communications. Access to the nomination process and being able to vote are necessary as they have a direct impact on committee membership and effectiveness. Those responsible for the assembly elections should ensure that these recurring issues, which in part seem to involve the distribution lists, are resolved.

Request for Consultations and/or topics that were not started or remain unfinished and need to be carried over to the next academic year.

The 2022-23 annual report highlighted a need to clarify membership eligibility and stipulate that individuals with administrative roles or responsibilities should be excluded from serving on the academic professional grievance committee. This requires amending Bylaw I of the constitution and bylaws. Academic professionals may need to independently propose these amendments as the Constitution and Bylaws Taskforce met this year, but there are concerns that the interests of academic professionals were not represented. In addition, the committee recommends clarifying the role of legal counsel in grievance hearings, which would benefit the effectiveness of all grievance senate committees.
