### **Overview Narrative:**

The following summarizes committee work accomplished throughout this past year:

Over the course of the academic year, the committee met monthly to consider a total of 124 curricular proposals brought before the committee, including 69 establishments of degrees, certificates, concentrations, minors, and academic units; 37 disestablishments of degrees, concentrations, and certificates; and 14 name changes. The committee also approved and provided recommendations to improve the Provost office's proposal to modify the university's undergraduate general education program.

This year was extremely productive for CAPC. We considered almost twice the number of proposals as we did in the last academic year (74), and, additionally, approved the Provost office's proposal to modify the university's undergraduate general education program while also providing significant suggestions for changes based on feedback from senators and other faculty stakeholders. Throughout the month of November, CAPC held one additional informational meeting in preparation of the CAPC vote on modifications to the undergraduate general education program and collaborated with the Provost's office in addressing faculty objections to the proposed modifications. We also invited the chair of the honorary degree committee to speak to CAPC about our committee's involvement in nominations as specified in CAPC bylaw.
