#### **Overview Narrative:**

Over the course of the academic year, the committee met monthly to consider a total of 81 curricular proposals brought before the committee, including 32 establishments of degrees, certificates, concentrations, minors, and academic unit; 30 disestablishments of degrees, concentrations, and certificates; 18 name changes; and 1 miscellaneous change.

This year was extremely productive for CAPC. Not only did we see almost a 20% increase in proposals we considered, we created a brief training video for future CAPC members. In addition, the committee devoted additional time amending CAPC bylaws. The bylaws were presented to the Senate and passed in April 2022. Further, CAPC discussed changes to the General Studies Program and sent a memo informing the Provost's Office and General Studies Committee of our concerns.

The entire committee recognizes that none of the good work of the committee could have been accomplished without the support and participation of Phyllis Lucie, who retired this year. Phyllis has guided CAPC as its coordinator with the Provost's office for years and will be sorely missed. The team is looking forward to working with Katie Jensen Ord, who will serve as the new coordinator.
