3. Informational Reports

a. Greeting from ASU Staff Council Representative

Patty Odle is the Staff Council president this year. Their goals include professional development and new ideas for collaboration. They have scheduled lunch and learns which are open to all. They have started a scholarship under staff helping staff. There are focused on employee engagement such as staff barbecues, all are welcome.

b. Associated Students of ASU (ASASU) Goals and Priorities for 2019-20: Presentation by Leah Jones, President of the Graduate and Professional Student Association (GPSA)

Leah Jones is the graduate student professional Association President. Their goals and priorities appear on the GPSA website. One issue they are working on reviewing whether student IDs can be used as voter IDs.

c. September 2019 meeting of Arizona Board of Regents (ABOR) and Arizona Faculty Council (AFC): Greg Stone, Tempe President-Elect, and Ann Sebren, Downtown President-Elect

Ann Sebren reported on the Arizona faculties Council meeting. Discussion included the ABOR Committee on Freedom of Expression annual report. There is a clear distinction between academic freedom in the classroom within the context of learning objectives set by disciplinary parameters and freedom of expression on campus. The Regents Cup is an inaugural debate coming up at the University of Arizona on November 16. The purpose of this debate is to increase civil discourse and democratic engagement. Also discussed was the first-year retention and persistence project and emphasizing the role of faculty in retention and persistence which will be the theme of the ABOR faculty breakfasts this year. Another topic discussed are the limitations of retention and persistence tracking data that focuses only on first-time, first-year students; perhaps other models should be explored that would include part-time, transfer and online students. The first reading of the revision to ABOR policy 2-224 regarding academic credit has been postponed until November. ABOR staff emphasized the importance of keeping faculty sovereign and their determining what counts as academic credit, especially pertaining to entry tests such as advanced placement. There was also brief discussion about general education policy and University initiatives that will be implemented over the next few years. Each university reported on current issues such as concerns about minority student safety, a need for training on racial bias by campus leadership and faculty, changes pertaining to the definition of faculty and inclusion of part-time and NTE faculty as well as salary compression and inversion.

4. UAC Chair's Report — Shirley Rose, Senate President and Chair of the University Academic Council

Jennifer Hightower from Educational Outreach and Student Services will be giving a report at a future Senate meeting about campus safety and facilities in response to a recent concern about elevators in the residence halls. Book orders need to be made by October 1 as addressed in ACD 305-05. Book orders need to be made by October 1 for spring and April 1 for the fall semester. The new faculty reception was held recently which is sponsored by the University Senate. There were 21 faculty members that attended. The lineup of speakers for upcoming Senate meetings is in development. Senators are invited to attend events sponsored by the Leadership Academy; the next workshop is on research innovation.
