1. Campuses Sound Checks

2. Call to Order

- a. Welcome from Senate President Shirley Rose (Presiding from Downtown Campus location)
- b. Quorum present with 98 senators in attendance

3. Informational Reports

a. Report from September ABOR meeting by Greg Stone, President-elect of the Tempe Campus Assembly

The Arizona Board of Regents meeting was held on September 20, 2019 at Northern Arizona University. A report on workforce development in Arizona was presented, including evidence that investment in higher education impacts overall economic development and the statewide distributed learning centers are

important to the state, especially as only 3 counties are expected to see job growth in 2030. ASU's capital improvement plan was approved which includes upgrades or renovations to the Bateman Physical Science Building, the Mill Avenue parking structure, the University pedestrian bridge, and the Herald Examiner building in Los Angeles. The Arizona Faculties Council was thanked for clarifying the distinction between freedom of expression and academic freedom so that ABOR could develop new policy on freedom of expression.

b. Report from PAC 12 Academic Leadership Coalition Conference by Stefan Stantchev, ASU Representative at Large to PAC12 ALC

Informational reports were provided by the universities in attendance. ASU reported on the general studies initiative and academic integrity policy which was in part developed by the University Senate. Member institutions discussed topics such as: student evaluations, emergency financial aid, merit raises, teaching evaluations, student conduct, campus safety, etc. As a follow-up to these topics, Senator Tracogna asked about multiyear contracts, that annual contracts lead to challenges with non-tenure eligible faculty recruitment and retention. Provost Searle stated that teaching professionals at other institutions have annual contracts and that there is an Arizona Board of Regents requirement that 15 percent of non-tenure eligible faculty can be on multiyear appointments. However, if a role is proven to be critical and a case is made, a multiyear contract could be given. After a year or two on annual contract, it is possible that a lecturer could go to a multiyear contract. Representative Stantchev indicated that the coalition will take these issues discussed and process the information shared and, along with President Rose, will bring relevant topics to the University Academic Council.

c. Progress Report on General Studies Revision, by Joan McGregor, Past-President of the Tempe Campus Assembly and member of the General Studies Task Force, 2017-present

A history of and current membership of the task force was presented. Existing general studies requirements have been in place since 1983. Revisions are being driven by concerns that students do not see a larger purpose to general studies requirements, they view them as a checklist. Current requirements also may not influence the skills and habits that are needed today. In addition, the Arizona Board of Regents wants to see revisions or at least have general studies reviewed so that graduates can engage with problem-solving and utilize knowledge and perspectives that transcend disciplines and cultures. They also would like general studies education to involve skill-based learning outcomes in key areas such as oral and written communication, critical thinking, etc. and produce lifelong learners. The new approach is thematic and will be based on four intellectual habits and skills: inquiry, collaboration, innovation and engagement to produce learning, persistence, adaptability and resiliency in order to solve problems in society. After taking an introductory course, students will move through the themes and a culminating experience. A pilot will take place at West campus next year. An open session will be held with faculty to discuss this new approach. More discussion will take place at a Senate meeting in the spring.

4. UAC Chair's Report — Shirley Rose, Senate President and Chair of the University Academic Council

Appointments were made to the Research and Creative Activities Committee as well as the Library Liaison Committee as listed in Appendix A. The University Senate President-elect will be selected in December. The Senate is working with the student government and University staff Council to identify common issues. The Student-Faculty Policy Committee will be working with the student government and a resolution they have proposed concerning removing barriers to voting.

Provost Searle was asked to provide an update regarding salary compression and inversion that the Personnel Committee previously addressed. Provost Searle reported that, as a result of the letter received last year, an analysis has been completed regarding tenure/tenure-track faculty salary compression and inversion. An analysis is underway pertaining to non-tenure eligible faculty. Deans should be addressing

this where it is self-evident; they will be factoring in faculty performance also. Some raises will be given on January 1 as part of this analysis.

a. Student and Faculty Policy Committee, Johannah Uriri-Glover

The Student-Faculty Policy Committee met in September to review the purpose of the committee as well as roles of the committee members. The also reviewed Requests for Consultation and set a regular meeting time. They met in October to review Requests for Consultation and working with the student government.

b. University Services and Facilities, Joyce Martin

The University Services and Facilities Committee met recently to review past RFC's including expanding the walk-only zones in Tempe to 5 p.m. which was accomplished. They also have addressed large car parking so that the driver view is not obstructed in the parking structures when approaching corners. They are considering additional issues including building maintenance and student access to UTO classrooms.

c. Library Liaison Committee, Cynthia Bolton

The Library Liaison Committee met in October. The Hayden library will be completely reopened in January and feature different purposes for different floors. The committee is also considering open-source publication and textbooks as well as library services for classes and textbooks on reserve.

Senator Bertrand commented on equity in faculty teaching, that faculty of color, especially women of color, tend to be more harshly evaluated and what is being discussed for alternative forms of evaluation. Senator Vandermeer referenced the topic of salary compression and inversion that was discussed and recommended that the UAC be involved in the discussion and creation of policy.
