President Rose reminded Senators of the upcoming academic assembly meeting to be held on Feb. 11. Simin Levinson, President of the Downtown campus assembly was elected to serve as UAC Chair and University Senate President-elect for 2020-21. Pamela Hoyle, former University Senate administrative specialist, will be retiring.

6. Report from the Provost of the University or Designee

Provost Searle indicated that the University has hit new marks in retention thanks to faculty and staff. Retention stands at 86.7 percent overall and 88.7 percent for Arizona residents and 93.1 percent for international students. The university moves up among research institutions according to the National Science Foundation Higher Education Research Development rankings, reporting \$641 million in research expenditures. This is quite an achievement for a university without a medical school or agricultural program. The University is working to address coronavirus concerns with the Centers for Disease Control and Arizona and Maricopa County Health Departments. A university website is available to provide current information. The coronavirus is typically spread through person-to-person contact and normal precautions should be taken, like the flu. There is one isolated case at ASU and the individual is being treated with over the counter medication. The university cannot say who the individual is, where they live, etc. Those who were in contact with the ASU individual were tested and are being monitored, no one has tested positive. Dr. Searle requested that faculty help curb xenophobia, it is the most concerning aspect of this situation. The university should conduct business as usual.

b. **Report on November 21 Arizona Board of Regents meeting** – Greg Stone, President-elect of Tempe campus Assembly

The Arizona Board of Regents (ABOR) received a report on the inaugural Regent's Cup competition that was held at the University of Arizona in recognition of free speech. ASU placed first in this competition. ABOR is considering existing policies regarding tobacco use at the 3 universities, including smokeless tobacco, and whether to merge 3 different policies into one. They also will be voting on academic credit policy to achieve consistency among the 3 universities and which AP scores qualify for academic credit. ABOR received a report on AZ Transfer and their new website. They were also updated on the general education initiatives at the 3 universities with the University of Arizona and Northern Arizona University scheduled to begin in August. ASU will

The U.S. faces a crisis with the demand for STEM professionals while the number of undergraduates who go into and complete STEM degrees remains stagnant. ASU is striving to achieve a 90% or better freshman persistence rate. Senate Motion #2020-33

Motion Introduced by: University Academic Council

Date of Motion: December 2, 2019

Title of Motion: Resolution Supporting President Crow's Statement on Free Speech, Civil discourse, and Student Conduct

Action Requested: The University Academic Council recommends approval of this resolution

Resolution

- Whereas, Arizona State University requires a robust exchange of ideas, for the intellectual development of students and the university mission of knowledge production;
- Whereas, Arizona State University has on occasion been targeted by individuals and groups espousing hateful ideas and rhetoric;
- Whereas, even hateful expressions are protected under the First Amendment of the U.S. Constitution and cannot be censored by the University;
- Whereas, speech in the form of threats to persons or groups is not protected under the Constitution or University policies; and

Whereas, on November 20, 2019, Arizona State University President Michael Crow issued via email and

subsequently made available onlineⁱ a University-wide statement articulating the University's commitment to protecting individuals' freedom of speech, simultaneously asserting the University's intolerance of all acts and speech that threaten the safety and well-being of individuals and groups in the University community;

Therefore, be it resolved, that the Arizona State University Senate, representing all faculty members and academic professionals,

- 1. publicly asserts and affirms support for President Crow's clear and timely statement of November 20, 2019;
- 2. remains committed to freedom of expression at ASU, as demonstrated through their adoption of the Chicago principles related to freedom of expression; and

3. will actively circulate this resolution to all members of the University community, including students, staff, and faculty.
