Minutes were approved.

3. UAC Chair's Report – Shirley Rose, Senate President and Chair of the University Academic Council

The University Senate, University Academic Council, the Senate Executive Committee, the Senate office, and university administration were thanked for their work and support this year. June 10, 2020 will mark the 50Th anniversary of the firing of Morris Starsky. More details will be circulated in a written report to follow.

4. Report from the University President: Postponed to Special Meeting on May 4, at 1:30pm

President Crow is attending the Arizona Board of Regents tuition hearing meetings this afternoon. He will meet with the University Senate next week to share his report.

5. Report from the Provost of the University

Provost Searle thanked the faculty for all they have done. Data from students and GetSet indicates strong support for faculty work and remote teaching. Decisions will be forthcoming soon pertaining to summer session B and the fall terms. The goal is to be open, but more information is needed. COVID-19 testing will continue to provide the proper sample to learn more about risk factors. Preparations are being made for fall, all options are on the table, including the possibility of different start dates. The way that terms are set up ASU – A, B and C is being looked at by other institutions. The clock extension for tenure-track faculty will be given to anyone, the extension is comparable to maternity leave, or health conditions where a faculty member can have an extra year to complete work with no added expectations. Faculty can also use the regular clock. No timeline or decision has been made pertaining to furloughs. Not enough information is available. Summer enrollment is down by 8% and the University did not receive the same state funding as last year. Declining enrollment is a serious issue, but it is too early to make predictions. The questions about Y grades – faculty need to inform students about changes to grading or the syllabus. Students are entitled to a letter grade. The University is also looking at salary compression of non-tenure eligible faculty. This was done in 2008 for all faculty. This issue will be revisited, not much can be done at this point. Twenty-five percent of university employees have young children, creating a challenge for those who are remote teaching and learning. The University needs to find ways to be supportive. The president will have more details when he meets with the Senate next week. The CARES act funding will go to Pell-eligible students for their expenses due to COVID-19. The University is still waiting on this money which will be added to financial aid. Pertaining to the summer session enrollments, data is not being shared among institutions, it is difficult to know what the national trends are. The University is conducting a regional enrollment campaign and focusing on visiting students. Faculty hiring has concluded, 125 faculty have been hired for Fall. There are 10 offers that remain outstanding, some faculty prefer to come in January.

Professor Wentz discussed Project Advance which addresses gender equity in STEM, including 3 initiatives that are underway. (click <u>here</u> for the presentation)

Professor Sweat is in the process of compiling answers from a survey that involved teaching and mentoring; he will provide more information at a later point.

The Arizona Faculties Council met to consider faculty involvement in the enterprise-wide Arizona Board of Regents metrics. The Arizona Board of Regents discussed several topics at their meeting, including COVID-19 and adaptability and resilience (click here for the presentation)

Those speaking in favor indicated that there was a comprehensive review by CAPC with members receiving and reviewing all documentation, the motion was considered and voted on in favor by the Spanish faculty, and the Spanish Linguistics Ph.D. is in high demand.

Senator Burton suggested that dates from the academic calendar be added so that faculty can plan for accommodating students. Senator Pittman suggested that the motion needs to be more specific; for example, how many elections are involved, what are the faculty options. Senator Pittman moved to send this back to the committee for revisions. Senator Burton and others indicated that this is an important issue for students, but timeliness is important. It should pass now so that faculty can plan for the fall.

Senator Hristovski recommended that IT staff be included in the previous Senate Motion 2020-79 recognizing essential workers. Senator Lyons mentioned there is interest in establishing an open access research fund. Finding a donor to invest \$1-2 million for this fund would support approximately 50-100 papers in a variety of topics per year. Senator Lopez advised that faculty have continued to pay for a parking pass that is not being used while faculty have not been on campus. Senator Pagan expressed appreciation for those involved with the general studies revision, it has been quite an undertaking.

Title of Motion: Launch of the General Studies Revision Pilot on the West Campus

Action Requested: The University Academic Council recommends approval of the launch of the pilot General Studies revision program at the West Campus

Rationale: The University Senate General Studies Task Force and the Office of the University Provost have developed a framework for conducting a review and revision of ASU's General Studies requirement, as requested by Arizona Board of Regents. In response to the Regents' request for a cohesive and coherent curriculum aligned with a set of educational values articulated by the Regents, an innovative approach to grouping and offering GS courses around themes has been developed and proposed to be piloted on the West campus in Fall 2020.

This thematic approach to General Studies proposed for the pilot can be viewed as an overlay to existing General Studies distribution requirements courses; however, the approach to general studies curriculum development is significantly different. Members of the University Senate Task Force presented reports to the Senate on the progress of their work on a revised General Studies model in March of 2018 and October of 2019; and a more detailed report on the substance of the proposed launch of a pilot at West Campus was presented to the Senate at its March 2, 2020 meeting. All ASU faculty were invited to participate in an April 6, 2020 forum dedicated to a discussion of the General Studies Revision with opportunities to provide input regarding the revision. About 175 people attended the forum.

As the General Studies revision is a modification to existing curricular offerings, it is a matter of procedure that members of the University Senate provide consent for the proposed launch of the pilot program on the West Campus in Fall 2020. Additionally, it is appropriate for the University Senate to consider a motion to establish guidelines for future stages of implementation of the revised General Studies model, if it is eventually considered for university-wide adoption. These guidelines should include a protocol for review, assessment, and consent of detailed theme proposals and other curricular innovation. This protocol for review should include the General Studies Council, The University Senate's Curriculum and Academic Programs Committee, and the University Senate.

Notes: Related Motion: This motion shares a rationale with Senate Motion SM 2020-81: The UAC recommends that the Senate, through its designated leadership group, the University Academic Council, establish guidelines for future stages of implementation of the General Studies revision program. Once a motion is advanced for a second reading and discussion, a motion can be made to postpone the discussion. A motion to postpone discussion requires a two-thirds majority and is not debatable, although a rationale for postponement should be offered.
