3. Informational Reports

a. Michael Crow, University President

Record numbers in retention, graduation and diversity also include a record number of applications to attend ASU. ASU continues to come up among top national universities in online searches. The number of out-of-state, international and in-state student applications has increased. Approximately 40,000 are currently enrolled in ASU online. Many students are enrolled in the college pathways programs and transferring from the community colleges.

In other developments, fundraising has increased significantly. Approximately \$321 million was raised this year, from both large and small donors. The endowment is currently at \$100 million. New buildings are under construction, including the Health Solutions Center at Mayo. New residence halls funded by private partners will be built at the Polytechnic and Downtown campuses. ISTB #7 in Tempe is the largest research building ever being built. Other projects such as office buildings, a hotel, parking, apartments and restaurants are all new construction in Tempe and part of the new athletic facilities district which will soon be moving off the University budget. A new bridge will be built that will cross University drive. Other construction is in progress at Sky Song. Mirabella is a senior living project underway in Tempe.

Faculty and staff have performed tremendously. The governor supports the University's budget which includes funding of the Arizona teachers Academy and eliminating the payment of an increase in health insurance premiums which was the result of a deficit in the Health Insurance Trust Fund. University finances are fine; however, one concern is gaining financial resources that can keep up with the pace the University needs. Faculty salary pools are being addressed this year. An ongoing challenge is to move away from central to college financial control. There is a need for Responsibility Centered Management at ASU.

In response to questions, President Crow indicated that there is interest in more endowment funding. In addition, a for-profit entity is being created to manage relationships with large and medium-sized corporations, comparable to the relationship with Starbucks.

b. Jeffrey Wilson, Faculty Athletics Representative

Faculty continue to help things go smoothly with student athletes. The Fall 2018 GPA was 3.19. For more information, click here.
