a. Bobby Hurley: ASU Head Men's Basketball Coach

The team is preparing for a new season. Work continues toward building a basketball program that emphasizes academic success and degree attainment.

### **b.** Jodi Preudhomme: ASU Title IX Coordinator and Special Counsel

The Duty to Report training launched in March. Approximately 14,000 employees have completed the training. Between December 2010 and March 2015, 30 cases were reported. From March 2015 to present, 38 were reported which indicates the training is working. Faculty can opt to disclose mandatory reporting and determine how they communicate this to students. The goal of the training is to facilitate a safe and secure environment for students, faculty and staff.

# 4. Senate Process Overview

### a. Chuck Barbee: Director of the University Senate Office

Chuck presented an overview of Senate processes to help those who are new to the Senate so that units can be represented effectively. He discussed the purview of the Senate, the role of the UAC, Senate committees, the informal and formal processes for conducting Senate business, the Senate meeting agenda, process innovations and the new website under development.

# 5. UAC Chair's Report – Brenda Hosley

Members of the UAC attended the ABOR meeting in June. Year-end reports were presented. The board approved the university budgets and tuition increases. The next ABOR meeting will be held at NAU on September 23-25.

The April 2015 Senator Spotlight featured Professor Manuel Barrera from Psychology.

The Fall Academic Assembly held on August 25 was well-attended, the largest turnout ever.

The Thunderbird School of Global Management continues to engage with the university. Bill Youngdahl is their first senator. The school also has a representative on CAPC.

Senate representatives are serving on two search committees: Elsie Moore is serving on the Fulton Schools of Engineering dean search committee and Judy Krysik is serving on the division of graduate education dean search committee.

Denise Bodman is serving another term as University Senate Parliamentarian.
