3. UAC Chair's Report — Simin Levinson, Senate President and Chair of the University Academic Council

The Arizona Faculties Council met on September 9, 2020. Dr. Rita Cheng, President of Northern Arizona University, will be retiring, and a search for her replacement is underway. The University of Arizona purchased Ashford University which will become part of their online university known as Global Campus. Budget requests were presented at the Arizona Board of Regents meeting on September 10, 2020. ABOR will be working with

the universities on metrics for online student learning success. This month's Senator Spotlight features Dr. Kristina Lopez from the School of Social Work on the Downtown Campus.

5. Report from the Provost of the University

Provost Searle indicated that, for the sixth year in a row, the University is ranked as the most innovative university and a top 50 public institution according to U.S. News & World Report. It was announced last week that in-person instruction will end at Thanksgiving and be remote after that, including exams. Extensive travel at Thanksgiving puts students at an unnecessary risk to return to campus after the holiday. Students will have a special opportunity to participate in the Innovation Quarter which will take place over winter break. It will feature noncredit workshops on prelaw, premed, coding, climate change, etc. The spring semester will not change, courses will be offered via ASU Sync. Spring break is still under consideration.

Dr. Vogel spoke on the issues pertaining to community assistants in the residence halls. They were given a choice whether to continue or not. Some are experiencing overwhelming anxiety. The administration is considering how well the University addresses student well-being. There is a good amount of fear, students need support and guidance. Some living in the residence halls have been moved around. Community assistants will receive additional training and support with more emphasis on processes and relational aspects.

In response to questions, Provost Searle indicated that the administration intends to work on supporting faculty. A peer learning application is in development. Students have sufficient notice and time to plan around the changes coming up for the end of the fall semester. The grading deadline will not change. The common final exam schedule will be discussed. Several faculty indicated they would like to support students in the residence halls. The goal of the Innovation Quarter is to engage students in different kinds of things; they will receive a smorgasbord of options. The deans will be soliciting faculty to participate in this initiative.

At present, there are 231 coronavirus cases among students, mostly off-campus. Three employees have tested positive.

b. Jodi Preudhomme, Title IX Coordinator and Special Counsel

According to Special Counsel Preudhomme, updates to Title IX policy stipulate that universities must provide fair and equal treatment of sexes in all areas of university campus life. The focus of last decade has been on sexual violence at college campuses. The Department of Education previously had provided guidance documents, but this summer, final regulations were presented. The provisions clarify that Title IX regulations apply to both student conduct and employee conduct. Title IX sexual harassment covers sexual assaults, dating violence, domestic violence, stalking, certain types of offensive conduct, and quid pro quo behavior in employment. Universities must have a Title IX process that includes a formal complaint process where an individual must

submit a written document. After review, the complaint moves to an investigation phase. A live hearing occurs with direct cross-examination of individuals. The university can only consider information that flows through this process to decide on a Title IX violation. The Department of Education states that universities maintain current policies such as a student code of conduct and university prohibition against harassment, discrimination, and retaliation. It will act regarding conduct that rises to the level of a violation. The regulations require supportive measures such as counselors, advocates, and crime advocates to both students and employees which the university already has. ASU faculty still are mandated reporters.
