### a. Adam Henry-Study Abroad

The study abroad program has offices on all campuses. The three areas to their program are: 1) faculty-directed programs where students go abroad with faculty members and experience focused study and have a cultural experience. Most study abroad students go on faculty-directed programs; 2) Partnership programs with partners all across the US; 3) exchange programs which is the most cost-effective program. They are interested in involving more students in study abroad. Money is often a barrier, there is an effort to look for outside funds. Approximately 1800 students currently are on study abroad; they would like to grow their program to 4000 participants annually.

Helene announced the election of Professor Brenda Hosley as the next UAC chair and University Senate President.

#### c. Committee motions

Senate Motion 2015-21 ACD 402 amorous relationships policy changes

Motion to approve made by Tompkins, second by Collins.

Tempe President Tompkins summarized the feedback the committee received from faculty about this policy, several issues had to do with the scope of the policy. President Ossipov indicated that the revised policy focuses on all students as well as the professionalism of faculty and provides clarity regarding professional boundaries. Senators reported that units reviewed the proposed policy and have issues regarding the scope and scenarios that needed further review.

Motion made by Wells, second by Horan to change the word *migh*t to *would likely* pertaining to exceptions involving approval for pre-existing relationships prior to ASU. (Location 4<sup>th</sup>- paragraph)

Final votes recorded 49 = yes 20 = no 11 = abstain Senate Motion to change the wording in 2015-21 was approved

Discussion followed about graduate students and whether they are covered by this policy. Motion by McPhee, second by Brian to delete the line in the policy that pertains to graduate students. (Location-3<sup>rd</sup> paragraph)

Final votes recorded 34 = yes 35 = no 9 = abstain Senate Motion to delete the line in 2015-21 concerning graduate students was not approved

Senator Alpers suggested this motion be returned to the committee. Alpers called for the question, second by Barnaby. Parliamentarian Bodman requested a motion to close the debate which requires two thirds of the Senate. Motion by Alpers to close the debate, second by Barnaby.

Final votes recorded 73 = yes 7 = no 0 = abstain Senate Motion to close the debate on 2015-21 was approved

A vote was taken on Senate motion 2015-21 as previously amended.

Final votes recorded 20 = yes 62 = no 1 = abstain Senate Motion 2015-21 was not approved

President Ossipov stated that although the motion failed, it will go back to committee for further review.
