4. UAC Chair's Report – Simin Levinson, Senate President and Chair of the University Academic Council

The University Academic Council has selected Eduardo Pagan, West campus President, to serve as the UAC Chair and University Senate president-elect starting in January. He will serve as the UAC Chair and University Senate president effective June 1.

6. Report from the University Provost

Provost Searle announced that Anne Jones will be serving as the new Vice Provost of Undergraduate Education starting this summer, replacing Fred Corey. A robust spring enrollment is anticipated. Faculty are asked to encourage students to enroll for spring and to not set their future aside.

Anne Jones presented an overview of the Innovation Quarter, a new initiative to provide students with something else to focus on that will advance their goals and aspirations. It is an opportunity to take advantage of a slightly longer winter break. Students will engage with the University in a different way. They can participate in non-credit courses, learn new skills, see a different side of ASU, and remain connected to the university. Several hundred options will be available. One of the opportunities includes contact tracing training. Innovation Quarter will begin with Innovation Week which will feature opportunities to develop an innovation mindset.

In response to questions, Dr. Jones indicated that the noncredit-bearing-courses were lightly vetted and there are no plans to assess the courses. Any proposed course with merit was accepted. It is not certain if Innovation Quarter will be offered at other times during the academic year. The sessions are also available to prospective students and community college students.

Provost Searle stated that the decision about spring break will be announced by the end of the semester. The search for the next University Provost continues and the selection will be announced very soon.

7. Other Reports

a. Elizabeth Wentz, Vice Provost and Dean of the Graduate College, ASU Project ADVANCE

Dr. Wentz reported on ASU ADVANCE, an NSF-funded initiative which is focused on addressing systemic challenges, examining institutional barriers, and increasing diversity in the professoriate across disciplines. First, they are looking at whether diversity and inclusion is incorporated at every level of decision-making at the institution. Second, they are studying professional development across career stages to include promotion and tenure and annual evaluations. The third focus is on a data dashboard to help inform units about their hiring, recruiting and promotion. The University has committed to a Provost fellow who will scale activities across the University. They also are looking at teaching bias in course evaluations and will continue working with the senate subcommittee to understand more about this issue.

In response to questions, Dr. Wentz mentioned that the analysis pertaining to teaching evaluations includes academic professionals who teach. Their work does not address the pipeline such as post docs or graduate students. She welcomes any research on teaching evaluation bias that senators would like to share.

b. Jillian McManus, Executive Director of Workforce Development and Health in the Office of Human Resources

Self-care is critical at this time; faculty can take an active role in their well-being. One way is through routines and rituals such as self-care, unplugging and using University resources that are available remotely. Access report here.

c. John Dallmus, PAC-12 Academic Leadership Coalition Representative, Fall 2020 conference update

The coalition discussed topics for the spring conference such as diversity in hiring, promotion and tenure, faculty evaluations, social justice issues and how new teaching modes affect faculty and faculty governance. They also discussed COVID response and budgetary stress at participating universities and how they are uniquely handling these issues.

b. Library Liaison Committee, Sarah Bolmarcich

The change from Web of Science™ to Scopus was explained, a decision made due to subscription costs and other reasons. Access report here.

c. Personnel Committee, Mary Jane Parmentier

The committee is addressing several Requests for Consultation such as the review of the merit pay system, unit bylaws, dependent documentation, and other topics. Access report here.

In response to questions for committee chairs, Sarah Bolmarcich indicated she would check into whether faculty will lose access to other services from Clarivate which offered Web of Science™. She also mentioned

that through the Arizona Library Consortium, the three universities work together to negotiate lower costs for electronic resources, but whether the universities share resources is not known. Web of Science™ citations can be moved into ASU Vita through the end of this year. She will ask if information is available and can be shared about how ASU's library investment compares to Northern Arizona University and the University of Arizona. Special circumstances drove the time frame for student evaluations this fall, it is likely the University will continue with the typical student evaluation timeframe for the spring subject to the pandemic.
