2. Call to Order

- a. Welcome from Senate President Arnie Maltz

- 3. UAC Chair's Report Arnie Maltz, Senate President and Chair of the UAC

Senators Johanna Uriri-Glover and Eric Kostelich were recently featured in the December and January Senator Spotlight. The university donor policy is posted on the University Senate website under documents. A new system is rolling out for hosting faculty websites, a beta site is available. Due to faculty requests, *Respondus* will be used for proctoring online math placement tests, helping to increase retention as well as graduation. Ed Plus will work with faculty to allow alternate student photo identification cards for O courses. For I courses, students should have a Suncard. A workshop on promotion strategies for NTE faculty will be held on February 14, 2018, further details will be distributed. Two items are a result of university Senate work: high performance computing is now available to all faculty and a University Safety Committee will be recognizing safe research practices through the development of a University Safety Innovation award.

4. Highlighted Committee Report

a. Research and Creative Activities Committee, Chair, Greg Stone

The committee is focusing on two issues, a pay to publish support program and developing programs that can assist faculty. In addition, additional resources are now available for high performance computing. More faculty now have a need for these resources, such as data analytics. The Office of Knowledge Enterprise and Development is assisting to help make high-performance computing user-friendly. A survey is under consideration to identify training needs.

b. Online Education Task Force, Chair, Jim Moore

The task force is reviewing the breath of online education, as well as incentives. Three subcommittees have been formed. They will be surveying faculty as well as chairs and online coordinators. Some future needs they are looking at include support for online education, student privacy, intellectual property, efficiencies, portability and control. A report from the task force is expected to be available in the fall. Senator Wells requested that the committee continue to look at the financial incentive issue as well as integrating outside packages and providers with Blackboard.
