- 4. UAC Chair's Report** – Senate President and Chair of the University Academic Council, Penny Ann Dolin. President Dolin noted that the Senator Spotlight in the Senate Dashboard for February is [Elena Rocchi](#), the program head and clinical associate professor of architecture at The Design School. She informed senators that nominations had been received for grievance committees and campus presidents, and that candidate information would be sent out in March. She also noted that President Crow had delivered a very detailed report on the **State of the ASU Public Enterprise and Arizona State University**, and she urged senators to examine this report.

Senate President-Elect Greg Stone reported on the ABOR meeting. After highlighting the ASU report and mentioning that that ASU has added a ninth design aspiration of "principled innovation," he noted that the regents had honored President Crow with the Regents Distinguished President Award. The regents passed a new tuition plan, pledging no increases in tuition if the state legislature provided the estimated 2.6% increase in appropriation needed for increased enrollment and inflation. The board also inaugurated a plan for community grants, with the first one focused on recruitment and retention of first responders. Finally, he noted the report from the Arizona Faculties Council, delivered by Chair Dolin, which emphasized the importance which faculty place on the guiding values of diversity, equity, and inclusion.

- 6. Report from the Provost of the University** – Nancy Gonzales, Executive Vice President and University Provost Gonzales began by touting the reopening on every campus of the [Open Door program](#), which invites the community to see what ASU is doing. She next addressed an existing problem which has become more serious recently: threats to faculty. Emphasizing that the university takes faculty and staff safety very seriously, she pointed to a web site on [threats](#) which contains important information on responses. She also explained that the university works with faculty, brings in police, will try to identify the source of any threats, and will bring in a response team.

The provost also described two new teaching awards, each to be awarded annually to one tenure/tenure-track faculty and one contract faculty. The [Provost Teaching Award](#) rewards excellent teaching; the [Charter Professor Award](#) is a three-year award for reflecting commitment to ASU's Charter: inclusion and success, research of public value, and responsibility for the well-being of the community. will also be awarded to one tenure/tenure-track and one contract faculty member.

## 7. Other Reports

- a. Sally Morton -Executive Vice President & Professor, [ASU Knowledge Enterprise](#). Vice President Morton provided a detailed [report](#) on of the structure of Knowledge Enterprise (KE), its support for research, its role in the New Economic Initiative, and the increasing scope of ASU research efforts. One of ASU’s three enterprise components (including Academic and Learning), KE provides research assistance to all campuses, and it supports 10 [institutes and initiatives](#) from biodesign to space to humanities. It supports the university’s research system in numerous ways such as facilities used, advanced computing, and infrastructure like compliance, finance and strategy. It also shapes ASU’s involvement in 7 innovation zones and partnerships across the Valley, including Phoenix Biomedical campus, NOVUS in Tempe, Sky Son, Discovery Oasis Health Futures Zone, and planned Innovation near the West campus dealing with manufacturing.

Vice President Morton noted that ASU’s research funding has continued to grow significantly, rising in the last year from \$677 million to \$797 million. This is reflected in ASU’s grant of \$40 million from the state to study water issues. And ASU’s has even greater prospects for the future, since it is competitive on a number of other, large projects. The university’s success is due to its talented faculty and its commitment to transdisciplinarity, something which the federal government increasingly recognizes as being valuable. The university’s increased success in these projects also benefits other researchers, for by improving the university’s reputation and visibility, it raises all “research boats.”

The third topic of Vice President Morton’s talk concerned the [New Economic Initiative](#). This multiyear project funded by the state of Arizona at \$50 million deals with matters like advanced manufacturing and materials, robotics, bioscience, digital media, and virtual and augmented reality. The state has specifically directed ASU to focus on creating [science and technology centers](#) (STC) to pursue research relevant to new industry initiatives, on training and retraining a workforce for the new economy, and on working with industry, encouraging entrepreneurship, and attracting new industry to the state. Two STCs – Energy and Materials, and Advanced Manufacturing – were started in 2021 because of the national support for microchips. Three additional centers have been started in 2022: Future Communications Technologies, Extreme Environments, and Human Performance. An STC is a consortium of researchers, entrepreneurs, subject matter experts and technologists in industry that define issues, solicit funds, and do research. STCs aid ASU by funding research, student training, and equipment. Faculty can become involved with an STC by either or submitting a successful proposal with an industry partner or participating in a Proposers Day – the next one of these is March 22, 2023 (Contact [stc@asu.edu](mailto:stc@asu.edu)).
