3. Regent's Report-Mark Killian, Chair of the Arizona Board of Regents

The following text outlines Regent Killian's comments to the Senate. More effort is needed to let the public and legislators know what the universities do. Universities are about more than transferring knowledge, they also are involved in the creation of knowledge. Everyone affiliated with the University should talk to everyone they know that universities are not cost centers but an investment. President Crow is doing well and has done much for Arizona. In response to questions from senators, Regent Killian stated that the message to the legislature should emphasize that universities pay taxes, create jobs, bring in money through research and spinoffs, as well as direct an enormous amount of money toward the economy. Universities are lean and operating like business, but they will take on the challenge to be even better.

4. President's Report-Michael Crow

President Crow stated that the University is at a difficult moment regarding raising tuition. Families are making incredible investments. ASU did not raise tuition last year. In-state students will experience the lowest tuition increase while out-of-state and international students will experience larger increases. He is expecting pushback from those opposed to increased costs. Due to the budget cuts, the University has experienced an operating loss of \$3,000 per student per year. He encouraged faculty to focus on innovation and creativity. In response to questions from senators, President Crow stated that ASU is an enterprise. The term, strategic enterprise framework, indicates no reliance on government or a bureaucracy. ASU is not like profit schools or government. Regent Killian suggested that faculty call legislators and ask them questions about education.

5. Faculty Athletics Representative Report-Jeffrey Wilson

Jeffrey Wilson reported that his role involves assuring that student athletes received a good education and that student athletes are a part of campus. Student athletes are served well and graduation rates continue to increase.
