2. Call to Order – The meeting came to order at 3:05 pm.

a. Total attendance taken and quorum requirements were met. **71** members were present.

3. University President's Report

President Crow addressed the senate and discussed several issues relating to the ongoing functioning of the University as well as discussing some of ASU's current rankings and provided some information on faculty salaries. 4. Provost's Report

The Provost report consisted of congratulating Senate President Joseph Carter as well as introducing the new Vice Provost for Academic Personnel, Dr. Barry Ritchie.

During the Provost report time period, Senate President Joseph Carter presented Senate Motion 2012-46, which allows the UAC to act on behalf of the senate over the summer break period, seconded by Arnie Maltz.

Senate Motion 2012-38 Proposal to Extend the Drop Period from One Week to Two Weeks

Cristi Coursen stated, the Committee heard this issue last year as a part of a drop/add proposal and there were many pros and cons expressed. The Student Faculty Policy Committee vote on this proposal was in the majority but it was not unanimous committee decision.

Discussion ensued outlining both the perceived pro's and con's of this motion

A friendly amendment was suggested to make a change in bullet #9 after the word integrity to say: "should proceed through the academic unit to the dean and then the provost. In order to track multiple violations, the ASU Office of Student Rights and Responsibilities should be informed."

Senator Ellsworth moved, and received a second, to strike the second sentence on bullet point #5: "Students should be reminded frequently throughout the semester, and with each assignment and exam."

A vote on this amendment occurred.
