- **4.** UAC Chair's Report Eduardo Pagán, Senate President and Chair of the University Academic Council President Pagán announced that a flat tire would prevent the provost from meeting with the Senate, that the Spring Academic Assembly was meeting virtually on February 8, that the Senate Spotlight for January is on Dr. Barbara Kinach, and that information about campus elections will soon be available.



The President also discussed why faculty should be interested in serving in the Senate. He noted that in the 2009 economic crisis the UAC met often with President Crow, being informed about issues and voicing faculty views on policy options. This direct access to the President and Provost is an effective and essential part of shared governance at ASU. Finally, the senate will be sponsoring discussions with the provost's office over the next few months over the proposed General Studies redesign.

# 5. Report from the University President

**6.** Report from the Provost of the University – Nancy Gonzales, Executive Vice President and University Provost. In the absence of Provost Gonzales, Vice Provost Deborah Clarke updated the Senate on Covid conditions, noting that the numbers were falling quickly. In response to a question, she explained that the federal mandate for contractors which includes ASU, is still on stay. To another covid-related question, she explained that faculty are eligible for up to two years extension of their tenure clock, that the impact of covid on all aspects of faculty job performance is complex, and that she would ask the provost to address this matter at a later meeting. Questioned about university policy on providing zoom links for classes, she noted that while an entire class could not be transformed into a zoom class, providing a zoom link is one of several options for assisting ill students. President Pagán responded to a question by noting that any questions and concerns about covid policy can be addressed to Senate leadership, as well as department heads and deans.

# 7. Other Reports

a. Carolyn Starr, Staff Council President.

President Starr explained the structure of the Staff Council, noting that each campus has a council. The Council addresses issues such as of work climate, professional development, advocacy, and financial aid. It sponsors events like blood drives, covid awareness, and employee appreciation.

b. Pamela DeLargy, Executive Director, Education for Humanity [meeting video 35:43 – 47:54]. The Director reported that as an official partner with the International Resettlement Agency, ASU has worked to aid faculty and their families, alumni, and Fulbright scholars in Afghanistan. In addition to hosting 10 Afghan scholars, it is also assisting 64 transfer students from that country. All of these students had previously attended the Asian University for Women in Bangladesh but had been sent back home to Afghanistan because of covid. These students were evacuated in September, sent to Wisconsin for orientation and language training, and are



now in the Valley. Faculty can assess their transcripts and provide advice about courses and disciplines. Perhaps 18 to 20 of these students may seek graduate degrees; others may seek a 2<sup>nd</sup> BA degree. Although 10 to 15 had limited English, 49 have excellent English skills. #### **10.** Senate Committee Reports

- a. Committee on Committees, Paul Carrese. Professor Carrese reiterated President Pagan's assertion regarding the importance of faculty leadership and involvement, both for the university and for the individuals, and he requested that faculty complete by February 21 the questionnaire regarding nominations for presidentselect of each campus as well as grievance committees.
- b. Digitally Enhance Teaching & Learning Ad Hoc Committee, Lisa Kammerlocher & Penny Dolin. The committee chairs reported on concerns about strategies for dealing with academic integrity problems. Among the suggestions were changing assessment and closing access to classes after the semester ends. University resources include the Provost's web site on academic integrity, library tutorial, an EdPlus pdf document.

- c. Personnel Committee, George Justice.
  The committee is awaiting a report from the provost on improvement for contract faculty. It is also seeking to get faculty involved in revising the course evaluation system.
- d. Research and Creative Activities Committee, Pauline Davies. Professor Davies reported on the committee's work on the issue of suing illegally obtained data. They produced a document which recommended consulting the IRB or the General Council. But the question remain as to what informed authority could advise faculty? One possibility is a committee of faculty, perhaps an ad hoc senate committee, but what if the university later disagreed with that recommendation? The committee consulted Vice Provost Ann Jones, who is consulting the Provost about this issue.
- e. University Services and Facilities Committee, Khaerannisa Cortes.



The committee is working on faculty input in the maintenance of their buildings and on making a simpler process for receiving accommodations to building use.
