# 4. UAC Chair's Report – Simin Levinson, Senate President and Chair of the University Academic Council

The newly elected campus presidents-elect were congratulated, including Maureen McCoy from Downtown, Scotty Craig from Polytechnic, Susanne Neuer from Tempe and Hala King from West. Election results are posted on the senate website. This month's Senator Spotlight features Hala King, Clinical Associate Professor, from the School of Mathematical and Natural Sciences at the West campus.

### 5. Report from the University President

University progress is at the highest level in every indicator including the number of graduates, capital campaign results, etc. This spring was more successful than last spring due to more research proposals than ever. The University was also of service to the community during the pandemic. The University will continue operating as an enterprise that generates its own revenue, consisting of three enterprise structures – knowledge, learning and academic. Fall 2021 will be a new normal as the University fully opens however it is uncertain what the new normal will be. All tools will be used whether vaccines, health checks, etc. to ensure that the University is fully functional. Several already have been vaccinated, including two thirds of the staff. About 18,000 students will be vaccinated in the next few days. The demand for ASU graduates exceeds the supply currently.

President Crow responded to questions and indicated that he would like everyone to be able to access medical care as transgendered employees and their dependents currently do not have transgendered medical care. Proposal data should be able to explain whether some faculty are more productive than others. Provost Searle added that the University can look at this, it was one of the reasons tenure clock extensions were provided. Schools in the University Innovation Alliance do not utilize the exact enterprise model that ASU does. The University Design Institute is helping train and design other universities. Money was invested to facilitate course delivery by Zoom, faculty can be creative with its use. Discussions are taking place as far as how Zoom can create more opportunities and flexibility for students. The priority is to reconvene classes in the fall, but Zoom might be available for certain cases. Counseling and mental health services are being accessed more now through Zoom.

## 6. Report from the Provost of the University

Provost Searle has attended every university senate meeting for the last 17 years. He yielded his time to Provost Pro Tem Nancy Gonzales who indicated that she is excited about the new model for the public enterprise. With 78,000 students expected to return in the fall, there is lots to do to prepare. It is expected that vaccines will be required for students this fall.

The assembly will be receiving a ballot to vote on the amendments to the Academic Constitution and Bylaws that were approved at the last university senate meeting. The election will take place April 28-May 4, 2021.

Tuition hearings were held, there will be no tuition increases this next year. The board received an update on food and house insecurity, policy recommendations are planned for June. The Arizona Faculties Council recommended that faculty and staff should be protected post-pandemic and it endorses the expectation that students be vaccinated.
