Most recent items the Senate is awaiting decision/response on.

- Feedback or approval of 17-18 Senate Annual Report

Hanging recommendations and/or implementation updates:

- RFC-120 Dependent documentation requirements: Per Senate committee chair Deb and Kevin Salcido were going to draft a letter asking for relief from this requirement. Once letter was complete the committee was to be provided a copy of the letter. Senate is interested in a formal confirmation of this for its records and to report to the faculty the final outcome.
- RFC-93 Parental leave when both parents are ASU employees: Arnie Maltz indicated administration is working towards trying to improve the dependent leave policies to better accommodate both ASU employed parents. Senate is interested in a formal confirmation of this for its records and to report to the faculty the final outcome.
- RFC-123 Four day per week summer school schedule: Per Arnie Maltz: the Provost has agreed to consider this proposal with the possible implementation of summer 2019. Senate is interested in a formal confirmation of this for its records and to report to the faculty the final outcome.
- RFC-26 Development of clearinghouse for academic dishonesty cases: Per SFPC chair Daniel McCarville: My understanding was Fred's team implemented the new PeopleSoft database (clearing house) that enables all of the various Dean's Offices to centrally record each completed academic integrity violation. Senate is interested in a formal confirmation of this for its records and to report to the faculty the final outcome.
