# 4. Informational Reports

#### a. Michael Crow, University President

President Crow reported that several records were broken this fall semester in several areas, including freshmen retention, graduation rates, freshman class size, diversity, academic quality and fundraising. Fundraising has increased by 8 times. ASU has exceeded \$600 million in research expenditures with more than 10,000 research projects and scores of awards. At a recent meeting, student government leaders indicated their interest in the well-being of students and helping students understand the quality of their education. Student leaders would like campus resources and experiences to be more equitable on each campus and they also would like more focus on school spirit, and a connection to ASU through sports, clubs, events, etc. After the upcoming elections, ASU will know more about where it stands with the legislature. Rather than emphasize the moral duty to fund the University, there will be more focus on the necessity of having universities. The goal is attaining support that amounts to half of the cost of attendance for in-state students. At this time, ~90 percent of university funding come from sources other than taxpayers. In addition, leveraging relationships with California will remain a priority. For example, approximately 85 percent of ASU venture- and investor-backed companies that originate from the faculty are backed by funds from California. More than 12,000 students from California pay full tuition. More than 1,000 employers in California seek ASU graduates. Several employers have facilities in both California and Arizona. In addition to the existing three realms of education (full immersion/technology-enhanced, digital immersion and digital immersion/open scale), another realm is emerging: education through exploration or gamebased learning such as ME3 which helps high school students identify a path to college. The University will be moving to more of a decentralized model and push colleges to be responsible for their own trajectories and resources. President Crow also advised faculty to be cognizant of students in distress and to engage students, connect them to resources and let them know they can be successful.

# **5. UAC Chair's Report** – Donna Cataldo, Senate President and Chair of the University Academic Council

This month's Senator spotlight features Stefania Tracogna from the School of Math and Statistical Sciences. The 2017-18 Annual Report is posted on the senate website; it also was distributed to university leadership. The academic integrity work group has developed a best practices list. The work group will be hosting campus visits to let faculty know what is happening. The Online Education Task Force is compiling survey data and a report is forthcoming. Senate Motion 2018-37 was approved and changes regarding the mandatory items for the syllabus now appear in the ACD. President Crow's written response to the Senate's request that faculty salaries be continually ranked in the top half our ABOR approved peer institutions is available on the Senate website under the documents section. Senate Motion 2018-32 concerning graders and TAs was not approved by the Provost, leaving units to decide with their faculty the appropriate resources for courses. The Personnel Committee requested ASU faculty and staff be relieved from the current health insurance dependent documentation requirement. The ASU administration agreed but could not act unilaterally to eliminate the requirement. On behalf of ASU, Kevin Salcido and Judy Cato drafted a letter to the Arizona Department of Administration requesting this requirement be eliminated. The Student-Faculty Policy Committee proposed a 4-day week summer schedule which was approved by the Provost and will be implemented during the summer of 2019.
