## 1. Update from Campuses & Sound Check

#### 2. Call to Order

- a. Welcome from University Senate President Brenda Hosley
- b. Quorum requirements met with 90 voting members present

### 3. Informational Reports

a. Provost Report, Mark Searle, University Provost

Provost Searle discussed tuition and the promise made five years ago to hold tuition increases to less than 3 percent for in-state students. Tuition will increase 1½ percent this year and is set at \$10,500 for in-state students. Tuition for undergraduate out-of-state and international students will increase \$1,000. Out-of-state and international graduate students will see an increase of \$1,100. The university continues to look at controlling costs for students given the limited investment from the state. The Arizona Board of Regents (ABOR) will conduct public tuition hearings on March 29, 2016. The tuition proposals will be voted on at the ABOR meeting on April 7, 2016. There is no word at this time on the status of the state budget request.

Deborah Clarke mentioned that a survey will go out to students and benefits-eligible faculty and staff. This survey is designed to capture university climate and inclusivity. It will ask questions such as have you have experienced a problem, who did you report it to and why? What have your overall experiences been? Are you aware of resources? Results will be tabulated anonymously by the Office of University Evaluation and released in aggregate form.

b. Kevin Salcido, ASU Vice President of Human Resources discussion on the Arizona State Retirement System (ASRS)

Kevin Salcido stated there is a proposal to consider adjusting ASU's relationship Arizona State Retirement System (ASRS). There currently are two plans: the Optional Retirement Plan or 401A plan where the university and individuals (employees) each contribute 7% of gross earnings and the employee decides how that money is invested. The ASRS, is a professionally managed plan where the individual (employee) and the University each contribute 11.5%. Proposed changes, due to cost include: no longer offering ASRS to new hires and to allow individuals who are not vested in the ASRS to join the ORP. The ASRS is made up of a mix of school districts, governments, etc. Mr. Salcido believes that ASU is the only ASRS member that passes 85% of costs to students, meaning that ASU cannot increase taxes to raise funding, but rather, must increase tuition to cover operating expenses. Cultural considerations for this proposal includes changes in the workforce where there is higher employee turnover and fewer employees who remain with one employer for their entire career. There is no impact of the proposed changes on current ASRS participants; the University pension plan is guaranteed by law and contract. The need for change involves ensuring ASU is receiving maximum return on the dollars invested in benefits and to address the overall costs associated for the ASRS plan.

c. Jeffrey Wilson Faculty Athletics Representative and Stevie Mussie, ASU Volleyball Coach

In the PAC-12, ASU is ranked number eight or nine for resources for academics. It ranks number two in the Pac-12 for return on investment of those resources, including an 84 percent graduation rate. The University Senate could be of assistance by ensuring all faculty consider the need for release time for student athletes to participate in athletic events. Coach Stevie Mussie was recently hired by ASU as the Director of Volleyball. Coach Mussie previously worked as an assistant coach at Penn State University. She stated that it is a big year for volleyball. They are currently ranked in the middle of the Pac-12 conference.

## 4. UAC Chair's Report - Brenda Hosley, Senate President and Chair of the UAC

President Hosley, Kathleen Puckett, Helene Ossipov, Chuck Barbee and Pamela Hoyle recently attended the PAC12 Academic Leadership Coalition conference at the University of Arizona. The issues that they are looking at include: climate/diversity, academic freedom and open access. Operating costs as well as development of a website are other areas the P12ALC is currently looking into. The next conference will be held at the University of Colorado in October of 2016. An ASU task force looking at open access is being considered for the 2016-2017 academic year. Brenda congratulated Judy Krysik from the College of Public Service and Community Solutions who

was selected for the March Senator Spotlight. Brenda asked senators to read ACD-125 and the university policy on Computer, Internet, and Electronic Communications Information Management. The University will be moving toward two-factor authentication to increase information security. The Arizona Board of Regents will be meeting at the University of Arizona on April 7 and 8, 2016 and the Senate will have four of its leaders attending.
