Second Read on Motion 2012-29

Senate [Motion 2012-29](#) New Academic Assembly Representation Model for the University Academic Council [Background Document Link](#)

The discussion was opened to the campuses:

Polytechnic President Jeff Thomas presented an amendment to SM 2012-29 that requesting that all schools/college in the motion and listed on the background document be allowed only one UAC representative. This motion applied to the College of Liberal Arts & Sciences which in the original proposal would receive 3 representatives. Seconded by Senator Forsyth

Discussion ensued on the amendment to SM 2012-29

At the conclusion of the discussion a vote was taken on the Polytechnic Amendment to SM 2012-29.

**Final Votes Recorded:            Yes=23            No=46            Abstain=9**

**The Amendment to SM 2012-29 was Not Approved**

A motion was made by Senator Ellsworth that the University Librarians are allowed representation in the new UAC model being proposed by SM 2012-29, seconded by Senator Miller
