#### 1. Campus Sound Checks

#### 2. Call to Order

- 4. UAC Chair's Report Eduardo Pagán, Senate President and Chair of the University Academic Council



President Pagan began his report by recognizing the achievement of Downtown Senate President Johannah Uriri-Glover, from the Edson College of Nursing and Health Innovation. The American Academy of Nursing has named her one of its distinguished nurse leaders, and she was the only Arizonan to be inducted into the 2021 Class of Fellows.

Pagan praised the efforts of faculty, administration, and staff to control the spread of covid, reporting that ASU has higher vaccination rates and lower infection rates than the surrounding community. Referring to a conflict between ASU students that was making the news, he reported that the Dean of Students was working with all students involved. Finally, he reminded senators that one of the Senate's priorities was working on the LIFT initiative, and that as part of that the Senate should look at course evaluations to ensure that they do not reflect any unfairness to faculty.

#### 5. Report from the University President

President Crow reported that the University is in excellent shape, with record enrolment from diverse sources, high levels of research activity with outside funding, and a significant increase in support for student counseling. The university continues to handle the covid situation well: random testing has produced rates under 1% positive for staff and below 2% for students, and the rates are declining. Students are excited about being able to be on campus. They and their families sacrificed considerably to be here, and their success is the university's primary goal. He also mentioned a conflict between students and explained that the administration was actively dealing with the situation, reminding all parties about the student code of conduct.

Turning to economic issues, he explained that although the university had suffered considerable economic losses due to the pandemic, especially in auxiliary services like housing, dining halls, and athletic events, it had weathered the storm and is currently in a solid financial position. As a result, a salary package has been sent to the deans and directors, for them to implement. The university is also benefiting from several new investment by the state: the New Economy program, which will support the expansion of engineering, an initiative regarding democracy, as well as other smaller programs. The university has had an active building program, including a new residence hall on the Downtown Campus, a new building with the Mayo Clinic, and a nearly completed Interdisciplinary building.

Asked about the difficulty faculty and staff face in finding affordable housing in downtown Phoenix, the President noted that ASU is working with apartment developers to create more affordable housing. While it can't offer a rental assistance program, ASU has increased the minimum wage for fulltime staff and plans to increase this to the level of a "living wage" for the area. At present, the university does not have a plan for assisting faculty, but the provost will look into this issue.

Another question involved a proposal by some students for open carry of firearms on campus.

President Crow noted that ASU includes children and adults of all ages, that having firearms on campus



is completely inappropriate, and that all Arizona university police chiefs have opposed this. The universities have successful defeated such proposals three times in the past decade, and President Crow expects the same result in this case.

Responding to a question regard the LIFT initiative, President Crow noted that the cochairs had be reappointed, that there was progress on all 25 initiatives (for example, the hiring of postdocs and new faculty had been completed), and that a report would be posted soon.

**6. Report from the Provost of the University** – Nancy Gonzales, Executive Vice President and University Provost

The Provost also noted that students are excited to be on campus. Campus enrollment increased 5.4% from 2020 because of student interest, but also because of the very effective work by faculty and staff to recruit and persuade students to re-enroll. Now, with so many first-time freshman and sophomores, it is crucial to continue this personal contact to integrate them into the university. Faculty concerned with assisting this effort should talk with their directors.

A wonderful launching initiative was held for one part of the LIFT project, the presidential postdoctoral fellowships and graduate fellowships. Schools interested in participating in this program will need to apply and show how these junior scholars can be integrated into the community. In response to a question, she noted that a large proportion of the graduate fellows and some of the presidential postdocs are African American, as were over a third of the faculty candidates brought to campus.

#### 7. Other Reports

a. Cassandra Aska, Deputy VP/Dean of Students

Dean Aska spoke about the Committee for Campus Inclusion, which she chairs. Each campus has a committee of faculty, staff, and students which is committed to advancing discussions about campus needs. They have fostered discussions about service and emotional support animals, about how to assist students who are parents, about the impact of systemic racism, about breaking the silence on sexual violence, and about the needs of the LGBTQ communities. She encouraged nominations for the annual Catalyst Award, which recognizes people at ASU who are working inclusion.

The Committee also provides guidance on advancing diversity initiatives at ASU, such as use of appropriate language and an appreciation of different celebrations and religious holidays.
